- 1. Request for Enrollment form;
- 2. Residency Declaration form, signed by a parent or legal guardian and;
- 3. Two documents reflecting identical current residence address including, but not limited to, any of the following (*Education Code 48204.1*):
 - Property tax payment receipts.
 - Rental property contract, lease, or payment receipts.
 - Utility service contract, statement, or payment receipt.
 - Pay stubs.
 - · Voter registration.
 - Correspondence from a government agency.
 - ** Amount of payments and other private information may be redacted. Residence is defined as the physical address of the applicant's primary parent(s)/legal guardian(s). P.O. Box addresses do not qualify.
